

OUR OLD MEETING ROOM HAS BEEN CONVERTED TO A PLAY ROOM WITH POOL TABLES ETC, BY THE CALLAHAN SENIOR CENTER. THIS ROOM IS AVAILABLE TO US FOR OUR COFFEE AND DONUTS AFTER THE MEETING AND IT MAKES A VERY COMFORTABLE ATMOSPHERE FOR AFTER MEETING GAB FESTS.

GEORGE BLAKESLEE NIGB CHAIRMAN OF OUR SCHOLARSHIP COMMITTEE GAVE THE FOLLOWING REPORT ON THE STATUS OF THE SCHOLARSHIP COMMITTEE: THE SCHOLARSHIP WAS PRESENTED TO TWO LOCAL AMATEURS OVER THE PAST TWO YEARS.

THE COMMITTEE WANTED TO REPORT TO THE MEMBERS ON WHAT THEIR EXPERIENCE HAS BEEN FOR GUIDANCE WITH RESPECT TO OUR CONTINUANCE OF SAID SCHOLARSHIP. PERHAPS THE MEMBERS MAY MAKE SOME CHANGES, PERHAPS THE MEMBERS WILL BE SATISFIED THE WAY IT IS.

TO REFRESH YOUR MEMORY, AT THE TIME THE SCHOLARSHIP WAS SET UP AS FOLLOWS; THE NINE POINT RESOLUTION AT THAT TIME WAS A SINGLE AWARD OF \$200.00 TO BE GIVEN IN THE NAME OF DR. CARLTON CROSBY, THAT AWARD HAS SINCE INCREASED AND IN THE PAST YEAR IT WAS \$400.00. THAT IT WOULD BE GIVEN-TO-ANY-STUDENT-ATTENDING-A PUBLIC OR PRIVATE SCHOOL WOULD BE POTENTIALLY CAPABLE OF QUALIFYING FOR SUCH SCHOLARSHIP. THAT THERE WOULD BE A GEOGRAPHIC LIMITATION OF APPLICANTS TO THE SOUTH MIDDLESEX COUNTY AREA INCLUDING ALL COMMUNITIES SERVED BY THE ASSOCIATION, IF THEY FELL OUTSIDE OF THAT RATHER NEBULOUS BOUNDRY SITUATION OF SOUTH MIDDLESEX COUNTY. THAT IT WOULD BE AVAILABLE TO ANY HIGH SCHOOL SENIOR WHO HAD BEEN ACCEPTED AT ANY ACCREDITED COLLEGE, WHO HELD ANY CLASS OF AMATEUR LICENSE. THAT THE FUNDS WOULD BE DISBURSED DIRECTLY TO THE STUDENT. THAT SELECTION WOULD BE MADE BY THE COMMITTEE ON THE BASIS OF NINE ITEMS. 1. GRADE POINT AVERAGE. 2. NEED. 3. EXTRA-CURRICULAR WORK IN ELECTRONICS. 4. ESSAY BY THE APPLICANT. 5. PUBLIC SERVICE ACCTIVITIES. 6. LEADERSHIP. THE COMMITTEE FOLLOWING THE MEETING WHEN THIS WAS APPROVED DEVELOPED AN APPLICATION FORM THAT REQUESTED INFORMATION IN THESE AREAS AND IN FACT THE ESSAY AND THE EXTRA-CURRICULAR WORK BECAME COMBINED INTO A SINGLE ITEM. 7. THAT IF NO QUALIFIED APPLICANTS WERE AVAILABLE IN A PARTICULAR YEAR THAT THE SCHOLARSHIP WOULD NOT BE AWARDED BUT WOULD ACCUMULATE FOR THE FOLLOWING YEAR. 8. THAT THE MEMBERSHIP RETAIN THE RIGHT TO CANCEL THE AWARD AT ANY TIME. 9. THAT THE SCHOLARSHIP COMMITTEE CONSIST OF THREE OR MORE MEMBERS SELECTED BY THE PRESIDENT OF OUR ASSOCIATION. THE PRESENT COMMITTEE ARE, GEORGE BLAKESLEE NIGB, ENZO ROTATORI WA1PYF AND JULIE HOFFER WIDL. IN THE TWO YEARS THAT FOLLOWED THE ESTABLISHMENT OF THE AWARD OUR EXPERIENCE HAS BEEN THAT IN THE FIRST YEAR WE RECIEVED SIX INQUIRIES AND TWO COMPLETED APPLICATIONS. IN THE SECOND YEAR WE RECIEVED FOUR INQUIRIES AND ONE COMPLETED APPLICATION. IN BOTH CASES THE DECISION OF THE SCHOLARSHIP COMMITTEE WAS THAT THE ! APPLICANTS WERE QUALIFIED AND AWARDS WERE MADE.

THE PRIMARY METHOD OF NOTIFICATION OF THE AVAILABILITY OF SUCH SCHOLARSHIP IS BY DIRECT MAIL TO HIGH SCHOOL GUIDANCE COUNCELLORS. ALL PUBLIC AND PRIVATE HIGH SCHOOLS IN THE SOUTH MIDDLESEX AREA WERE CONTACTED, THEY ARE: ACTON, CONCORD, DOVER, HOLLISTON, HOPKINTON, LINCOLN, MARLBORA, MAYNARD, FRAMINGHAM, MEDFIEDD. MEDWAY, MILFORD, NATICK, NEEDHAM, NEWTON, NORTHBORO, SOUTHBORO, STOW, SUDBURY, WAYLAND AND WESTON......

ATTEMPTS WERE MADE BY ENZO WA1PYF TO GET THE AVAILABILITY OF THE SCHOLARSHIP ANNOUNCED IN THE SOUTH MIDDLESEX NEWS BUT THE ATTEMPT WAS NOT SUCCESSFUL. IN 1980 WE ATTEMPTED TO HAVE THE WINNER PUBLISIZED BUT RECIEVED NO PRESS.

THE COMMITTEE WANTED TO REPORT WHAT THEIR EXPERIENCE HAS BEEN AND WILL BE HAPPY TO ENTERTAIN SUGGESTIONS ON HOW THEY CAN IMPROVE OUR OPERATIONS. PUBLICITY IS ONE PROBLEM THEY SEE, THAT MAY EXIST. THE OTHER PROBLEM IS WE HAVE BEEN TO LIMITING IN OUR GEOGRAPHICAL COVERAGE AND MIGHT CONSIDER A WIDER AREA. THE THIRD POSSIBILITY IS WE NEED TO ELICIT MORE SUPPORT ON THE PART OF THE MEMBERSHIP IN BRINGING TO OUR ATTENTION PEOPLE AND ACTUALLY BE MORE AGGRESSIVE IN CONTACTING

POTENTIAL APPLICANTS IN SOME MORE DIRECT FASHION. THE COMMITTEE FEELS THE SCHOLARSHIP WAS AN ASSOSIATION AFFAIR AND THEY HAVE NOT ATTEMPTED TO TAKE ANY ACTION OF THEIR OWN AT THIS POINT........ A DISCUSSION PERIOD FOLLOWED WITH MANY GOOD SUGGESTIONS BEING MADE BY THE MEMBERS PRESENT AS TO HOW TO OBTAIN MORE PUBLICITY AND COVERAGE............. ALSO UNDER DISCUSSION WAS SHOULD WE TERMINATE THE SCHOLARSHIP AND DONATE THE MONEY TO A LOCAL CHARITY, SUCH AS BOY SCOUTS, RED CROSS, CIVIL AIR PATROL ETC. THEIR WERE MANY DIVERGENT OPINIONS ON THIS SUBJECT THAT WILL BE RESOLVED AT A LATER MEETING..... IT WAS DECIDED TO WAIT UNTIL A FUTURE MEETING TO DECIDE THE AMOUNT OF THE SCHOLARSHIP FOR THE 1982 SEASON AND TO CONTINUE IT FOR ANOTHER YEAR..... OUR GUEST SPEAKER FOR THE EVENING WAS DON BLACK KA1BTY, COMMUNICATIONS OFFICER A CAP SQUADRON AT HANSCOM FIELD, HE ALSO IS INVOLVED IN THE AIR FORCE MARS PROGRAM. HE IS COMMUNICATIONS OFFICER FOR THE ARLINGTON CD AND CHAIRMAN OF THE MMRA PUBLIC SERVICE COMMITTEE, THE LARGEST REPEATER -ASSOCIATION IN NEW ENGLAND. DON GAVE A VERY INTERESTING LECTURE ON THE AIMS AND PURPOSES OF AIR FORCE MARS...... "MAC" OUTLINED WHAT WE AS A GROUP CAN DO FOR THE TOWN AND SURROUNDING AREAS AS COMMUNICATORS. HIS COMMENTS AND SUGGESTIONS WERE VERY WELL RECIEVED AND WE CAN EXPECT TO BE USED IN ANY UPCOMING SITUATION. REQUIRING COMMUNICATORS. IT IS UP TO US HOW WE RESPOND TO A CALL-UP. IF THEY CALL ON US AND NOBODY SHOWS UP, IT WILL BE A LITTLE DIFFUCULT TO ASK THE TOWN OF FRAMINGHAM TO HELP AND RESPECT US AS AMATEURS...... GOOD NEWS FOR AMATEURS !! WHEN THE ANDOVER BYLAWS CONCERNING TOWERS WENT TO THE STATE LEGISLATURE TO BE APPROVED, THEY DELETED ALL REFERENCES TO RFI BEING THE RESPONSIBILITY OF THE AMATEUR OPERATOR.

THIS RULING BY THE STATE WILL GO A LONG WAY TOWARD MAKING A FAIR JUDGEMENT WHEN THE SURROUNDING TOWNS DECIDE TO MAKE AN ORDINANCE ON ERECTING TOWERS. THE AMATEUR OPERATOR CANNOT BE EXPECTED TO CORRECT THE MISTAKES OF THE MANUFACTURERS WHO PUT OUT POORLY DESIGNED CIRCUITS THAT ARE SUSCEPTIBLE TO INTERFERENCE.....

ICOM IC2AT - A PHENOMENA - A SOLUTION: SALES OUTPACE PRODUCTION. LIKE ANY NEW PRODUCT, SOME PROBLEMS OCCURRED. THE COMMON PROBLEM IS THE FAILURE OF TRANSISTOR Q-8. ONLY A SMALL PERCENTAGE OF RIGS HAVE BEEN AFFECTED, THE MYSTERIOUS FAILURE HAS BEEN TRACED BY ICOM TO STATIC DISCHARGE. WHEN THE UNIT IS CARRIED ON A PRESONS CLOTHING BY THE BELT CLIP, RAPIDLY REMOVING IT UNDER HIGH STATIC CONDITIONS CAUSES A DISCHARGE TO THE METAL SERIAL NUMBER PLATE AND IN TURN, INSIDE THE CASE. CHANGES WHICH WILL PRECLUDE THIS PROBLEM ARE;

ADD A 2.2K RESISTOR FROM THE BASE OF Q-8 AND GROUND IT. IN ANY EVENT, THESE CHANGES SHOULD NOT AFFECT THE PERFORMANCE OF THE RIG....TNX CORC REPEATER NEWS.....

THE TELEPROMTER CABLE COMMUNICATIONS CORP, WHOSE CATV INTERFERENCE TO AMATEUR APERATIONS IN RICHLAND, WASH. WAS ISSUED A NOTICE OF APPARENT LIABILITY FOR FORFETTURE IN THE AMOUNT OF \$2500.00 BY THE FCC. THE CITY OF RICHMOND HAD ALSO COMPLAINED TO THE FCC THAT TELEPROMPTER WAS VIOLATING THE COMMISSION'S RULES BY INAGURATING ITS NEW, EXPANDED FREQUENCY CONFIGURATION WITHOUT PROPER FCC AUTHORITY......
