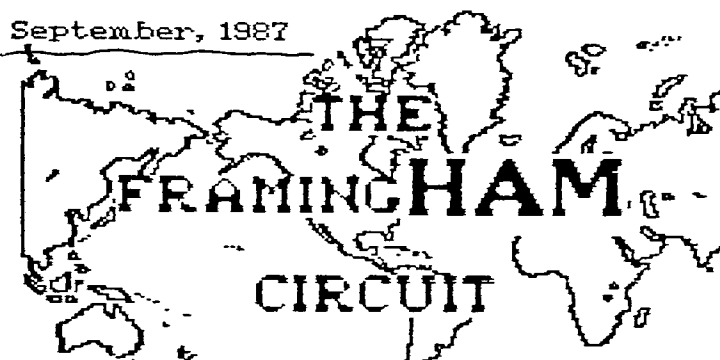

MINUTES OF THE SEPTEMBER, 1987
MEETING OF THE FRAMINGHAM AMATEUR
RADIO ASSN. INC.

The September meeting of the Framingham Amateur Radio Assn. opened at 7:37 p.m. with Burt Shaffer, N1DDO, president in the chair.

After member introductions, the first order of business was the reading of the June minutes, which were accepted on voice vote, and then the treasurer's report was read and accepted.

Burt then opened the first business session of the year. the topic of discussion turned to the flea market. Burt noted that Lew Nyman, KI4ZE, chairman of the event, had asked that an early signup be called for so the size of the crew could be gauged. Burt then spoke about the Flea Market and what it supports and some discussion ensued. A signup sheet was passed around. It will again be passed around in October. The Flea Market is Oct. 25.

Burt also noted that FARA has been called upon to assist with the Amateur Radio weekend at the Museum of Science, Sept. 26 and 27. Lew, formerly ARRL Affiliated Club Coordinator, has been asked by the committee running the event to run the HF station. Because of this Burt asked for volunteers to help Lew out.

Another signup sheet was passed around and a number of volunteers signed on.

Moving to a new item, Burt noted that the club may want to give thought to an Amateur Radio Emergency vehicle, a resource which

we lack. He thought it would be a good way to generate some interest and support both from club members and the community. A spirited discussion then ensued about the need and merits of such a vehicle. The consensus was that the matter be studied as to the merits, cost and liability and that a report be given to the club.

Burt had an interesting idea about rebuilding the club treasury, periodic in-club auctions, where members would bring in equipment and other things for consignment and members would bid on it. The member would get the profits and the club would get a percentage for the treasury. An alternative suggestion was that members bring in small items, with the items auctioned off for a dollar or two. During the discussion, several members suggested a raffle. The matter was left for further discussion.

Jon Weiner, K1UUC, Flea Market committee member, suggested that an "early bird" fee for those who want to get a chance to get in and see the items at the Flea Market early.

In other business:

* Ted Gruber, WB1ECE, has volunteered to take over the newsletter as editor.

* Classes were delayed until Oct. 10 so that they can be advertised at the Amateur Radio weekend at the Science Museum. Registration will be held weekly at the club station until then. Ed Weiss, W1NXC, is chairman.

* Burt noted that we can use a library classroom for Saturday morning classes for a nominal fee. It will save us many headaches.

* The club approved the donation of Amateur Radio educational materials to the library. An appropriation of \$90 was made so the library can place a set of ARRL publications and educational literature on the bookshelves.

* The club was notified by letter that we have been renewed as a special service club.

The meeting adjourned at 8:16. Marc Stern, N1BLH, Secretary, District Emergency Coordinator for Weather Services -- ARRL, discussed the club's role in public service work and some upcoming events. A social hour

followed.
